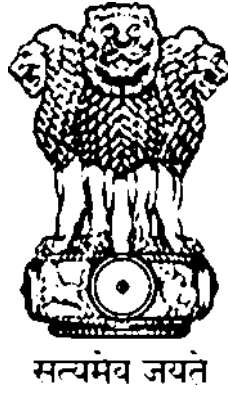

**Agenda 8.9 Review of Shortlisted Experiences for DPR Package -1**

1. Based on the review of Master Plans (Iteration-01) Strategy and Action Plan presented by various PDMCs for remaining destinations, the experiences in para 2 have been shortlisted for end-to-end tourist experience improvement plan as per guidance note issued.
2. The following shortlisted interventions were presented by respective PDMC teams for the following destinations.

3. The Committee reviewed the above shortlisted experiences presented in the meeting and following observations were made:
  - (i) With regards to Borra Cave Experience at Arakku in Andhra Pradesh, it was suggested to plan an interpretation centre also and PDMC and State to connect with Geological Survey of India to showcase geological significance of the caves.
  - (ii) For Indus Valley Civilization Experience at Dholavira in Gujarat, it was suggested to propose only those components which are native and in-sync with the site characteristics. A joint meeting of ASI, State,

Ministry of Tourism and PDMC to be conducted to ensure ASI is fully on board.

- (iii) For Spiritual Experience at Bundi (Keshavraipatan) and Bundi Art Experience in Rajasthan, it was suggested to avoid heavy concrete structures and too many experiences and concepts, which have been clubbed. It has to be ensured that whatever is conceptualised is amenable to implementation of the project in one year and the operate and manage it on sustainable basis. The State would accordingly review the experience.
- (iv) With regards to Eco-Wellness Experience at Yuksom Cluster at Gyalshing in Sikkim, it was suggested to avoid proposing components which are not in sync with the destination's USP and keep the experience as natural and serene. Operation and management on sustainable basis has to be worked out along with the concept. Heavy concrete structures should ordinarily be avoided.
- (v) For Prayag Darshan Experience and Azad Park Experience at Prayagraj in Uttar Pradesh, it was suggested to include marketing and promotion of these experiences also, which will be essential for success of these experiences.
- (vi) For Vedic- wellness Experience at Naimisaranya in Uttar Pradesh, it was suggested to keep the experience as simple and serene and not make it a spa resort. It was suggested to explore Gurukul as part of the experience.
- (vii) The committee accordingly approved in principle the proposed concepts for the tourist experiences at various destinations for further detailing and preparation of DPR's. States were directed to submit the DPR of the shortlisted interventions by the 4<sup>th</sup> of December 2023 with assessment of readiness of project after incorporating the feedback received and the guidance note in this regard.
