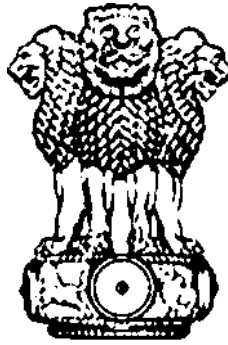

Agenda 1.2 Confirmation of proceedings of the first meeting held on 21/6/22

First meeting of the Mission Directorate was held on 21/6/2022 and the proceedings of the meeting were issued vide number SD-8/15/2020 dated 23/6/2022. The same are attached. The proceedings may be confirmed.

Agenda 1.3 Progress of Submission of State Perspective Plans by the States

1. As per the guidelines, the States/ UTs are required to submit the State Perspective Plan via online portal to assess the major destinations, theme, status of tourism ecosystem and top 5 destinations proposed to be developed under the Swadesh Darshan 2.0 Scheme in order of priority.

2. The format of the State Perspective Plan has been circulated to all the State Governments vide **OM No. SD-8/15 /2020-SD dated 20.04.2022**. The online portal - (<https://nidhi.nic.in/SwadeshDarshan/Login.aspx>) for submission of State Perspective Plan by the State/UT has been set up. A presentation on the format and portal was made in the last meeting.
3. Few observations and challenges while uploading the information in the SPP portal were highlighted by the states. However those technical issues have been now resolved.
4. States/ UTs are requested to submit the State Perspective Plans duly approved by State/ UT Steering Committee at the earliest. It may be pertinent to mention that the destinations will be sanctioned based on first come first serve basis subject to the availability of funds, adherence to the scheme guidelines and past performance of the States.
5. No SPP has been received so far. The current status will be reviewed in the meeting.

Agenda 1.4 Progress on State Institutional Structure and Empanelment of PDMC

1. One of the key reforms in Swadesh Darshan Scheme 2.0 is to provide for well laid out State Institutional Structure. The States are accordingly requested to notify the State Steering Committee and State Nodal Officer. The Destination Management Committee will be notified after the finalization and sanction of the destinations by the Ministry of Tourism.
2. A presentation on broad outlines for empanelment of PDMCs were presented during the 1st MD meeting. Subsequently, Draft RFQ has been prepared and the same is annexed for suggestions and feedback.
3. The current status of State Institutional Structure and feedbacks on the Draft RFQ will be reviewed in the meeting.
