**Agenda 1.1 Leave of Absence**

**Agenda 1.2 Confirmation on proceedings of the 1st Meeting**

**Agenda 1.3 Submission of State Perspective Plans by the State**

1. The States/ UTs were requested to submit the State Perspective Plan as per the requirement of the scheme guidelines, to assess the major destinations, theme, status of tourism ecosystem and top 5 destinations proposed to be developed under the Swadesh Darshan 2.0 Scheme in order of priority.
2. The current status was reviewed in the meeting.

**Agenda 1.4 State Institutional Structure and Empanelment of PDMC**

1. NPMU presented the salient features of State Institutional Structure as contained in the guidelines of the Scheme. The States were informed that one of the key reforms in Swadesh Darshan Scheme 2.0 is to provide for well laid out State Institutional Structure.

2. The States were requested to expedite notification of the State Steering Committee and State Nodal Officer.
3. NPMU presented the salient features of the RFQ document for empanelment of PDMC circulated with the agenda. Major aspects related to draft RFQ were discussed in the meeting including:
  - (i) Indicative Team Structure
  - (ii) Indicative Milestones and Payment Structure
  - (iii) Deliverable Timelines
  - (iv) Consideration of Minimum Eligibility
  - (v) Technical Evaluation Framework
  - (vi) Empanelment Terms
  - (vii) Selection of PDMC by State from Empanelment List
4. It was informed that the Ministry will accordingly finalize the RFQ and process for empanelment will be completed at the earliest.

**Agenda 1.5 Status of Submission of O&M Details for Completed SD 1.0 Projects**

1. The status of submission of O&M details under SD 1.0 was discussed. It was informed that these details are required in respect of all the major components of the project as per the list supplied by the Ministry and in the format prescribed by the Ministry.
2. It was noted that following States have submitted the information:
  - (i) Chhattisgarh
  - (ii) Kerala
  - (iii) Manipur
  - (iv) Meghalaya
  - (v) Mizoram
  - (vi) Sikkim
  - (vii) Telangana
3. All the remaining States were requested to expedite submission of the requisite details.

**Agenda 1.6 Review of fund Releases of SD 1.0 Projects**

1. The status of pending releases of funds were discussed and it was requested to expedite submission of pending UCs, tendered costs and other formalities.

2. It was pointed out by State of MP that the requisite details have been submitted long back and the same needs to be reconciled at the Ministry's end. NPMU was asked to reconcile the details and circulate the updated list.
3. All the States were accordingly requested to expedite submission of necessary documents for release of funds.
4. It was also informed that future releases would be in accordance with the revised procedure instructed by Ministry of Finance and the States have already been informed about the same.
